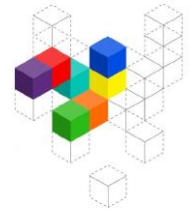

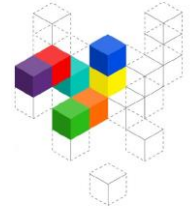

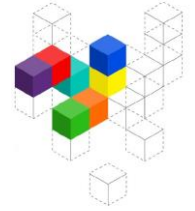


LEI Contract

1. The Legal Entity Identifier (“LEI”) is a unique identification number for legal entities. The LEI is registered by Strate (Pty) Ltd as a Local Operating Unit (“Strate”) in terms of guidelines issued by the Global Legal Identifier Foundation (“GLEIF”). The objective of the LEI is to offer a method of identifying unique legal entities in order to promote transparency and risk mitigation for financial transactions.
2. The issuance and renewal of LEIs is subject to requirements established by GLEIF.
3. An LEI is only valid once an LEI certificate has been issued by Strate to the applicant.
4. Use of the Strate LEI service, whether for initial registration (“issuance”) or for annual extensions (“renewal”), is subject to these Terms and Conditions of Use.
5. Notwithstanding termination in terms of clause 6 below, these Terms and Conditions shall endure for as long as the applicant exists, or as long as Strate exists, whichever is the shorter.
6. Termination of these Terms and Conditions shall immediately occur in the event of:
 - (i) a transfer of the applicant’s LEI to a different Local Operating Unit or to GLEIF;
 - (ii) the applicant abandoning its status as a legal entity with an LEI;
 - (iii) a withdrawal of the LEI by Strate due to non-compliance of the applicant with the re-validation requirements;
 - (iv) severe or repeated violations of contractual duties, for which no remedy is possible, or where no remedy has been made despite a reasonable period having elapsed;
 - (v) in the event that Strate’s status as a Local Operating Unit, or the Master Agreement between Strate and GLEIF, is terminated by GLEIF. In such instances, Strate will not be liable for any damages.
7. The applicant must ensure that all information submitted to Strate is accurate, correct and valid at the time of making the application.
8. All applications must be submitted by the applicant’s duly authorised representatives, signed and dated.
9. Where any application is made by a person on behalf of an applicant, such person must provide proof of that authority.
10. Each applicant may only apply for one LEI globally.
11. The applicant is responsible for the accuracy, correctness and validity of any information that is submitted in support of an application for issuance or renewal of an LEI.
12. If incorrect information on the identity of the applicant is supplied, Strate has the right to refuse the application. In such instances, no refund of any fees shall be made.
13. The applicant must, on an annual basis, review its information on the Strate LEI register and verify the accuracy of such information. Any updates to the information must be reported to Strate immediately.
14. If any person wishes to challenge the information contained in the LEI register, such challenge, together with supporting documentation, can be submitted to Strate-LEIHelpDesk@strate.co.za. Strate will review and investigate any challenge received and report back to the person who raised the challenge and the affected LEI on any actions that have been taken, if any, and the reasons for doing so.
15. The applicant acknowledges that the Strate LEI register is a publicly accessible repository of LEI information. The register provides information on the identity of the applicant and other legal entities in an unrestricted manner, free of charge, and free of any rights.
16. To the extent that applicant may, under present or future copyright legislation, enjoy intellectual property rights over the LEI information, such intellectual property rights (of whatever type, extent or legal nature) are hereby irrevocably transferred (or, if that is not possible under the applicable legislation, irrevocably licensed) to Strate.
17. Strate may be required to amend certain information of the applicant on the Strate LEI register due to legal requirements or internal controls.
18. The applicant acknowledges that GLEIF reserves the right to transfer the applicant’s LEI information to another Local Operating Unit under certain circumstances.
19. The applicant may request to transfer its LEI from Strate to another Local Operating Unit, at no cost.



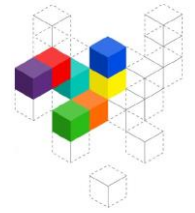
20. The fees for Strate's LEI service, which apply to the issuance, renewal and transfer of LEIs, are contained in a fee schedule available on this website, or on request.
21. All fees are subject to an annual review. In the event of a lower fee being introduced, the applicant will not be entitled to a payback of fees already paid.
22. The applicant must make payment to Strate within 30 days of receiving the invoice. Strate will only begin the process of verification of information once payment is received.
23. The information on this website is for general information purposes only, and no rights can be derived therefrom. While Strate has exercised diligence and care to ensure that the information contained in the LEI register is complete and accurate, Strate will not be liable for any damages to any person, of whatever form and howsoever caused, that may result from any inaccuracy or omission in the information, nor from any reliance that any person places on the contents of this website.
24. Strate does not vouch that this website will function without interruption.
25. Strate reserves the right to amend the information, layout and access rights of this website, including these Terms and Conditions of Use, at any time and at its sole discretion.
26. These Terms and Condition of Use are subject to South African law. The applicant submits to the exclusive jurisdiction of the High Court of South Africa, Gauteng South Division, in respect of any action or proceeding arising from this agreement.
27. The language for all formal notifications in respect of Strate's LEI service shall be English.



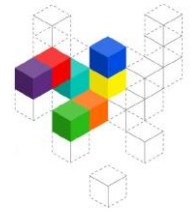
Service Levels

Register	<p><u>Non-validated applications</u></p> <p>Strate will communicate by email advising the applicant of the non-validation issues. Update	<p>Strate provides an interface or mechanism for legal entities to update their LE-RD. Challenge	<p>Strate reviews and responds to LEI or LE-RD challenges transmitted to Strate by GLEIF. Such challenges may be transmitted to Strate by GLEIF on behalf of a third party or on behalf of GLEIF. Strate researches the content of the challenge and verifies the challenge via an authoritative data source. Strate promptly informs the legal entity about the receipt of such a challenge and gives the legal entity an opportunity to comment, and/or to apply for a change regarding its LEI or LE-RD. If the challenge is verified by and an authoritative data source, Strate will ensure that the LE-RD is adjusted, taking into account the comments it has received from the legal entity. Terms of Use of the Strate LEI Service

INTRODUCTION

A. The Global Legal Entity Identifier Foundation (GLEIF) is a not-for-profit foundation incorporated by the Financial Stability Board in Basel, Switzerland under the laws of Switzerland.

B. GLEIF and its partnering Local Operating Units ("LOUs") operate a system of worldwide unique Legal Entity Identifiers ("LEI", "LEIs") and LEI repositories with certain additional information about the relevant legal entities ("Legal Entity Reference Data", "LE-RD").

C. The website <http://www.lei-strate.co.za> allows users to access the LEI Register of Strate. Any such access might use file downloads, access via Web Interfaces/APIs or by any other technical means, as provided in Strate's discretion. Any data LEI and LEI-RD access at <http://www.lei-strate.co.za> is subject to these Terms of Use.

1. DEFINITIONS

"**Strate LEI Service**" shall mean the facility provided by Strate under these Terms of Use and further described below, and provided on the website <http://www.lei-strate.co.za>.

"**Strate LEI Register**" shall mean the database operated by Strate with at least all LEIs and LE-RD managed by Strate.

"**GLEIF Logo**" shall mean the logo of GLEIF as shown on <http://www.gleif.org>.

"**Strate LEI Logo**" shall mean the logo of the Strate LEI Service as shown on <http://www.lei-strate.co.za>.

"**GLEIS**" shall mean the Global Legal Entity Identifier System operated by GLEIF and the LOUs.

"**LEIs**" shall mean Legal Entity Identifiers issued by GLEIF and the LOUs.

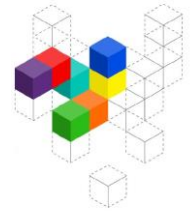
"**LEI Reference Data**" and "**LE-RD**" (singular and plural) shall mean the information available in the Strate LEI Register in relation to an LEI. The categories of data currently included in the LE-RD are listed on <http://www.gleif.org>

"**LOU**" or "**LOUs**" shall mean the Local Operating Units who have entered into a Master Agreement with GLEIF and who are accredited by GLEIF to accept applications by legal entities for LEIs and to issue LEIs. A list of the accredited LOUs can be found on <http://www.gleif.org>
Strate is an authorised LOU.

"**ROC**" shall mean the "Regulatory Oversight Committee established by the Financial Stability Board and which has set out binding recommendations which can be found on: http://www.leiroc.org/list/leiroc_gls/tid_163/index.htm.

"**We**", "**us**", "**our**" or equivalent terms shall refer to Strate.

"**User**", "**You**", "**your**" or equivalent terms refer to any user of the Strate LEI Service.



2. STRATE LEI SERVICE

2.1 The Strate LEI Service enables Users to look-up and/or download individual LEIs and/or related LE-RD and/or the entire set or a subset of LEIs and/or pertaining LE-RD from the Strate LEI Register.

2.2 The Strate LEI Service on the website <http://www.lei-strate.co.za> is provided for free.

2.3 The data available through the Strate LEI Service are provided under the CC0 licence, see <https://creativecommons.org/publicdomain/zero/1.0/>.

2.4 In order to protect the GLEIS and the fundamental principles underlying it as set out in the recommendations of the ROC, in particular in the event of any use of the Strate LEI Service which is contrary to, or threatens to undermine, those fundamental principles or the public benefit for which LEIs and LE-RD are provided, we do have to reserve the right to suspend or modify the Strate LEI Service or any of the Terms of Use.

3. SERVICE LEVEL

4.1 By using our Strate LEI Service, you agree with the following terms:

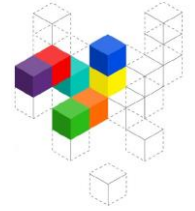
